OLD BUSINESS

Approval of Minutes

BJ Schuller moved and Patti Hickson seconded the motion to approve the December 6, 2021 minutes. The motion carried.

COMMITTEE REPORTS

Treasurer

Patti then went over the proposed budget for 2022. Individual items were discussed and modified as needed. B.J. Schuller made the motion to approve the 2022 budget as discussed and Sharon Skoworn seconded the motion.

Vice President -

Sharon Skoworn is working on the charity event to raise money for St. Mary's Food Bank. We still need players and donors. Mary Dyrseth will send out a reminder flyer to the members.

Tournament Chair

Mary Perry is preparing for the February 5 club championship and has proposed the following amended passages for the Standing Rules, to be put in place before that event.

- II. Major Tournaments
 - C. OLGA Cup (Low Net Tournament)
 - 3. Tournament shall be in flights. Players shall be paired according to playing handicap and shall be assigned to flights based on the players Lakes/Palms playing handicap. Handicaps shall be updated as necessary for subsequent rounds, but players shall remain in the flight assigned on the first day of the tournament. The subsequent rounds shall be paired within flights according to standing.
 - D. Club Championship (Low Net Tournament)
 - 3. Tournament shall be in flights. Players shall be paired according to playing handicap and shall be assigned to flights based on their Lakes/Palms playing handicap on the first day of the tournament. The subsequent rounds shall be paired within flights according to standing.

A motion was made by Linda Thrash to approve the change to "playing handicap" based on the Lakes/Palms course. Motion was seconded by BJ Schuller.

Handicap

Linda Thrash reports that we have 145 total members. Of those 116 are golfing and 29 are handicap only. 35% will be playing from silver tees, and that list will be sent to the pairings committee. Phyllis has been given everything she needs for the 2022 directory.

BJ Schuller has lost one member of the pairing committee and another member has volunteered to help on a temporary basis until that spot is filled. B.J. is updating the manual and will also clean up the managers' list to reflect only those who should currently have access to the program.
